We are excited about showing your work at the Hale Springs Inn. In order to exhibit, we ask that you understand and agree to the following conditions:

1. It is the artist's responsibility to deliver, install, and remove his/her work according to the dates above.
2. All work needs to be **ready for presentation (appropriate framing required.) Only original work** can be displayed, no prints. The artist will use the **10 easels** that are supplied by art show director, unless other options are discussed ahead of time. More art may be displayed on one small table, window sill, and or fireplace mantel.
3. Artwork is exhibited at the artist's **own risk**. Hale Springs Inn will take reasonable measures to monitor/protect the artwork, but **cannot be responsible for damage or theft**. The Hale Springs Inn does not have insurance for artwork.
4. The artist will provide a **bio/resume** and **jpeg images** used for press releases (newspaper, facebook, website), due no later than **4 weeks before the show**. Hale Springs Inn will publicize the exhibition. The artist gives permission to distribute this information/reproduce images as it relates to publicizing the show.
5. Artwork may be for sale. **All artwork needs to be labeled** with Title, Media, Size, Artist Name, Artist Phone Number, Price. The artist will handle all sales transactions. Hale Springs Inn will not handle any transactions. The artist may sell artwork and replace with new piece during the show.
6. **The artist needs to attend the artist reception, held on first Wednesday of each month from 6-8 PM**. There will be no refreshments provided by Hale Springs Inn.
7. The artist understands that after the reception the artwork on the easels, may be moved throughout the facility.
8. The artist has the option to do a give-away drawing to collect addresses.
9. Hale Springs Inn does not have storage space and cannot be responsible for work left behind. At 30 days after the end of the show, any leftover work will become property of the Hale Springs Inn and may be disposed of.
10. The artist understands that the purpose of the Hale Springs Inn is not the same as a venue such as an art gallery or art institution. The purpose of the Hale Springs Inn is to serve as a welcoming and neighborly food and meeting place for a diverse clientele that includes adults and children of all cultures. The artist must acknowledge the importance of this distinction, and select work for exhibition accordingly. The Hale Springs Inn or the art show director reserves the right to make final decisions about works displayed at Hale Springs Inn space before or during the dates of the exhibition.
